Khamsuanhang Zou at Langol Housing Complex Q. No. G-77, Type- III Lamphelpat,, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 15,00,000/- (Rupees Fifteen Lakhs) only comprising of my household item and personnel assets was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
