These criminals broke the gate of my quater and completely looted every valuable properties burning/destroying the rest from my quarter premises worth **Rs.21,50,000/-** (approx). Fortunately, me and my family managed to escape from these criminals who could have kill or burn us alive.

Therefore I humbly requested you to take strong necessary actions against the perpetrators by registering **ZERO FIR** under relevant criminal sections of the **Indian Penal Codes**.
