Subject: Report on vandalism, looting/ robbery and missing of property/(ies) that took place on 4th May, 2023 at about 03:00 – 04:00 PM at Qtr. No. E/69, Type – III Langol Housing Complex, Imphal.

Sir,

I, the undersigned, a victim presently taking relief / shelter at Vaalveng, New Lamka have the honour to state the following for your kind intervention and favourable action that, on 4th May 2023 at around 03:00-04:00 PM, as there are groups of heavily armed Meitei goons armed with deadly sophisticated weapons roaming around, we ran and hide in fear of our lives. Meanwhile, there Meitei goons forcefully entered my quarter mentioned above, and looted/ robbed all the valuable household goods/ items inside and vandalizing / destroying all the remaining items which are not looted. Further, our two-wheeler Pulsar Bike bearing Redg. No. MN05B 6449 and our newly purchased Ntorq, No. A/F are missing and could not be found/ traced till date.

That, the estimated value of all the properties destroyed, looted and robbed is estimated to be worth approximately Rs. 15,00,000/- (Rupees Fifteen Lakh) only.

Being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
