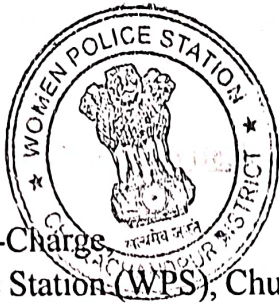

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of
TYPE - III / D-71, LANGOL HOUSING COMPLEX 1, IMPHAL WEST.....

That, on the 3rd JUNE, 2023 at 8.00 a.m./p.m. my above said residence
(Owned/Rented) was attacked, destroyed, looted and burned by a Group of Meeitei/Meitei
radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property
from my "Owned / Rental" House, and premises worth Rupees..... 6,50,000 (Approx.)
and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei radical groups
were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK
YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family for being a
tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by
registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
