Property Stolen & destroyed of Mr. Stephen Chinkhanson Guite & family.

Native of Vengnuam, New Lamka, Churachandpur, Manipur-795006.

Residing in Qtr No. E-9, Type IV, PWD Qtrs, Lamphelpat, Imphal, Manipur-795004.

The incident took place on 4th May, 2023 (Thursday) in the afternoon at 2:00pm near 86 CRPF Lamphel. Our family (Myself, Wife, barely 3 months old baby & maid) barely escaped our residence after which our house was attacked. All our belongings are looted & vandalised (completely destroyed). Our new Mahindra XUV 700 was fully damaged using iron rods, i20 Hyundai Car was stolen/burnt, our Honda Activa was stolen/burnt along with all our household items.

My house was subjected to a horrific act of vandalism, where miscreants (Meiteis) broke into my property & looted all our valuable possessions. The perpetrators completely damaged causing extensive damage and rendering it inhabitable.

This has not only caused financial loss, but also emotional trauma for me and my family and the loss will not be able to be recovered for the rest of my life. Now, I am left with nothing as I had to run for my life and had a narrow escape from death. This horrific and unwanted incident has had a profound impact on our lives, and we feel violated and unsafe in our own homes. Even though 144 CRPC was imposed in the State, it is heartening that violent is happening even in the heart of the city, that too besides CRPF Camp, Lamphel. We tried seeking help from Police, CRPF but it was all in vain.
