Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to Assam Rifles Mantripukhri for our safety and finally left the camp on 8th May, 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
