Subject: "Request for Registration of Zero FIR"

Sir,

I, B.K Simte of Quarter No C 19 Zone 3 National Games Village, Imphal, am bringing to your kind notice that on the 4th May, 2023 (in broad daylight) my residence was attacked by a group of goons (numbering about 150-300) suspected to be members of Arambai Tengol, Meitel Leepun and others.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx.) Rs 8,50,000 (Eight Lakhs and Fifty Thousands) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to 143rd BN CRPF Lamphel for our safety on the same fateful day and finally left the camp on 4th May 2023 for airport.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
