Subject : Report of ransacking, plundering, ravaging and looting of my quarter, T-A  
73, Zone-3, National Games Village, Imphal West and an attempted  
lynching of my family by Meitei mob.

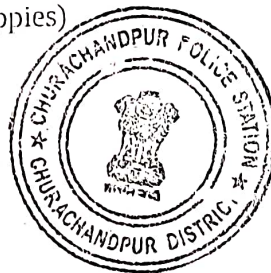
I am submitting a report of ransacking, plundering, ravaging and looting of my quarter as well as attempted lynching of my family by Meitei mob who were believed to be volunteers of Arambai Tenggol as a part of their ethnic cleansing pogrom of the Kuki-Chin-Mizo community.

That, around 5:30 p.m of 4<sup>th</sup> May, 2023, a group of weapons, sticks and iron rod bearing youths speaking Meitei/Manipuri, who were believed to be Arambai Tenggol volunteers numbering about 20-25 came knocking at the gate of my government quarter at National Games Village and enquired about my identity. On ascertaining my tribal identity and my origin as Churachandpur district, they shouted "HAO HATLO" and attempt to lynch me and my family. There was a great commotion for some time between us and the volunteers and before they could deliver destruction to our lives we escaped in vehicles and somehow reached 1<sup>st</sup> MR Bn. In the process, my vehicle glass was broken and my driver received a head injury too. We stayed in the 1<sup>st</sup> MR relief camp till 10<sup>th</sup> May, 2023.

When I visited the government quarter on 10<sup>th</sup> May, 2023 at 7 a.m, I found my quarter's front door broken and opened. As I entered, I saw the household items scattered all over the place and many things missing. Some missing items that I could remember at the moment are:

1. Godrej Iron Chest containing money, valuable items, gold necklaces, rings
2. 50 inches Mi Tv
3. Microlab 5.1 surround sound
4. Hartke amplifier speaker
5. Cort Acoustic guitar with carry case
6. Guitar stand
7. Lyrics stand

9. 2 kid bicycles
10. 2 Luo is Philippe suites, 4 blackberry formal shirts.
11. 2 brand new formal shoes (Hush Puppies)
12. Stand fan (Bajaj)
13. Epson 2100 colour printers.

15. 3 mobile phones (all Redmi)
16. Microwave oven

18. Sony a7R4 camera
19. Camera lights with stands, camera tripod
