Subject: Complaint regarding acts of theft and looting – request for registration of a Zero FIR.

Sir,

With reference to the subject cited above, I would like to lodge a complaint regarding the acts of theft and looting unleashed by a violent mob allegedly belonging to the Meitei/Meetei community on my properties and personal belongings in the early hours of the 4th of May, 2023 and which continued sporadically thereafter at my Brother-in-law's Government Quarter at Zone-III, Type-A, Quarter No. – 56 (Near Mary Kom Boxing Academy), National Games' Village, Imphal West – 795 004, Manipur.

In the mayhem, the miscreants dismantle my vehicle (a cyan metallic Yamaha Cygnus Ray ZR 125 bearing registration No. MN02G 7557) [Copy of RC attached] and took both the front and rear alloy tyres, also damaging the seat.

When the marauding mobs attacked, we are compelled to flee and had to take shelter in the 143 Battalion CRPF Relief Camp, Near Lamphelpat DC's Office, Imphal West – 795 004. As I no longer feel safe in Imphal, we have no choice but to relocate to Churachandpur.

In view of the above facts and circumstances, you are requested to kindly:

- i) Register a Zero FIR.
- ii) Facilitate an investigation into the events prior to and leading to the incidents of vandalism, theft, arson and looting and book the culprits immediately so as to prevent the recurrence of such undesirable incidents in future.

Thanking you in anticipation as I look forward to a favourable consideration of my request for registering a Zero FIR at the earliest.
