SUBJECT: Report about armed robbery, arson and dacoity.

Sir,

I am to bring to your notice that on the 03 MAY 2023, between 6:30 PM and 04 MAY 2023 6:00 PM, the rented house where I am a tenant located at, House No.3, Paite Veng, Sangaiprou, Imphal West, Imphal - 795001 was looted, destroyed and burnt by a group of armed Meitei/Meitei's gangs numbering around 500 men.

These criminals broke open the gate and looted anything they considered valuables, and burnt down the remaining properties. The estimated lost and damages caused may be valued at Rs. 7,32,200.00/- approximately.

Rupees Seven lakhs thirty two thousand two hundred.

With the help of military personnel myself and my two daughters', namely, Miss. Vunghianem (14 Years) and Miss. Dimsawmching (16 years) luckily escaped without any serious injuries.

It is therefore my sincere prayer that, due course of action may please be initiated against the perpetrators of the heinous crime in accordance with the law.
