I hereby write this letter to draw your attention that in the past few days i.e., on the
4th of May 2023 @ 10:00 am, Qtr. No. D/36, Zone III National Game Village, situated
at Lamphelpat, P.S. Lamphel, Imphal West- 795004, was attacked by a group of
armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of
Rs. 15,00,000/- (Rupees Fifteen Lakhs) only comprising of my household item and
personnel assets was looted, vandalized and gutted/burnt down by the said armed
meetei/meitei radicals.

Therefore I kindly request you to please take action in this matter and come
up with positive solution.
