I hereby write this letter to draw your attention that in the past few days *i.e.*, on the 4th of May 2023 @ 07:00 pm, the quarter allotted in my name at Hq No.28 Type-II CP Quarter situated at Lamphelpat, P.S. Lamphel, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 31,46,000/- (Rupees Thirty One Lakhs Forty Six Thousand) only comprising of my household item and personnel assets was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Vengnuam New-Lamka.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
