Sir,

I, H.Douchinthatg Quarter No B71 National Game Village Imphal, am bringing to your kind notice that on the 3th May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mobs.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx.) Rs 14,47,700 (Fourteen Lakhs Forty Seven Thousands Seven Hundreds) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to CRPF Camp New Keithelmambi for our safety on and finally left the camp on the 9th May, 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
