Sir,

I, **Pastor H.Kamkhanlal** of Changangei Uchekon Imphal, am bringing to your kind notice that on the 4th May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mobs.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the value of **Rs 10,23,100 (Ten Lakhs Twenty Three Thousands and One Hundred) only**. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to 1<sup>st</sup> MR (Manipur Rifle) for our safety on the 4<sup>th</sup> May, 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.

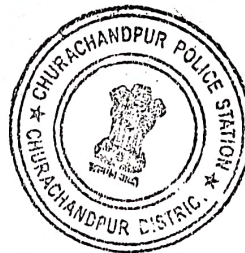
