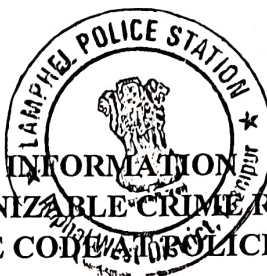

Subject: "Request for Registration of Zero FIR"

Sir,

I, Th.Kaithian s/o of Changangei, Uchekon Imphal, am bringing to your kind notice that on the 4th May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mobs.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx.) Rs 10,42,600 (Ten Lakhs Forty Two Thousands Six Hundreds) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to 1st MR (Manipur Rifle) for our safety on the same fateful day and finally left the camp on 9th May 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
