

I may be allow to bring to your kind attention that on the 5<sup>th</sup> May, 2023 at around 1:00 PM, at the residence of Ex- MLA Shri Ginsuanhau Zou, Changangei, Ucheckon, P.S. Patsoi, Imphal East District, Manipur, where I am attached and detained as his ( Shri Ginsuanhau Zou) Personal Guard Commander, our combat equipment like Wireless Hand Held Set ( 4 in nos.) and 2 (two) set of Set top box attached to one pilot vehicle were destroyed and burned down along with the pilot vehicle by a groups of unruly goons belonging to the Meetei/Meitei community.
