## **FIR STATEMENT FOR IMPHAL SCHOOL OF PREACHING**

On the fateful day of May 4, 2023 the staff members and the students of Imphal School of Preaching have to evacuate the buildings of the staff quarters and hostel of the Bible school as we were informed of the burning, looting and destroying of moveable and immovable properties

nearby our locality in which most of them are Kuki-Zo peoples. With no security and no other means of protection we fled away at the nearby 165 Territorial Army Camp next to the Imphal Airport, which is about 2 km from the Bible School at around 9:00 a.m. Due to limited time and as we were running for our lives, we could not retrieve any of the office documents which includes the Pucca Patta (Jamabandi)/land documents of Imphal School of Preaching, Registration Certificate, Trust Deeds, Sale-Deeds and all other important documents of the Imphal School of Preaching.

All the staff members along with their family members stayed at the Territorial Army camp along with one of our Kuki students where the other students happens to be from the Naga community and they could be safely evacuated from the hostel by their family members and as such, no harm was done to them and they could safely reached their village. After two sleepless night and three fearful days, on the 6th May, 2023, we could finally get tickets for Aizawl via Agartala via Kolkata to Aizawl with the help of the Director's relatives who lives in Aizawl.

Due to the current situation prevailing in Manipur and as the Bible School property and building have been burnt down and completely destroyed, we do not have any option to return back to Imphal until the situation subsides. Hence we are filing Zero FIR at the nearest police station in Churachandpur.
