We would like to state that we are permanent settlerinGamngaiVeng, Phaipijang, Langol, Imphal but due to volatile Riotviolence, dangerous Arsonic, Rampaign looting, collapsed of Law and order etc inImphal since the night of May 3, 2023situation compelledus to leave behind our home & properties and seek refugeein 86thBn CRPF Camp, Lamphelpat, Imphalfor safetyof our life on 04.05.2023. Then Left Imphal for seeking safer placesoutside Manipur State on 07.05.2023 asunabet violence, arsons, killings, etcwere out of control andworsening day by day.,

- 2. Secondly, 3 number of our Borewell Drillingmachines along with spare parts &accessories etc which wereleft and abandoned by us at Langol Area where drilling works were going onuntil this incidence was not happened on the previous day (03.05.2023). We strongly suspected that our machineries/properties werealso not safeany more since reports of Non stoparsonic activities, mass looting & damaging, burning down of public properties etc by unknown miscreants has been reported from the Langol localities every now and then which we could notconfirmed tilldate (10.06.2023).

In view of the situation asstated above, I humbly request you to kindly Registered FIR for unknown status of abandoned properties which were suspected to be Damaged/looted/burnt down by unknown miscreants Immediately and shall be highly appreciated, if you could kindly inform us the action taken up by you in this regards and lets know status of our properties under report at the earliest
