- 2. As you are aware of reports/happenings of rampaging looting, burning downand damaging of public propertiesby unknown miscreants in Langol Area, Imphal since the night of May 3, 2023. Weare worried and concerned about the safetyof House & properties constructed onPatta land bearing Patta No.84/209 (New) cover by CS Dag No 1111under 91/Meitei Langol Revenue Villagelocated below Hill Colony, Langol, Imphal – 795004 but safety status of ourproperties which could not be confirmed by us till date (10.06.2023)

In this connection, I humbly request you to kindly Register FIR for unknown status of abandoned properties which is suspected to be Damaged/Iooted/burnt down by unknown miscreants Immediatelyand shall be highly appreciated, if you could kindly inform us the action taken up by you in this regards and let us know the status of properties under report at the earliest.
