KEPT INSIDE THE KUTCHA HOUSE & COMPOUND OF MY UNDER CONSTRUCTION HOUSE
LOCATED BELOW HILL SIDE COLONY, LANGOL IMPHAL
ON THE PATTI LAND BEARING PATTI No 84/209 (New) CS DAG-No 1111 AREA 0.1342 Hectare
UNDER REVENUE VILLAGE OF 91/ MEITEI LANGOL**

I regret to state that due to Volatile Riot Violence, arsonic attacks on human life, killings, burning down of public properties etc in our Locality, Langol, Imphal from the night of May 3, 2023. Our family is compelled to leave Langol leaving behind our House and Properties for safety & security of our life and took refuge in 86BN CRPF Camp located at Lamphelpat on May 4, 2023 and as the situation is worsening day by day, we left Imphal for seeking safer places for our life outside Manipur state on 07.05.2023.

2. As you are aware of reports/happenings of rampaging looting, burning down and damaging of public properties by unknown miscreants in Langol Area, Imphal since the night of May 3, 2023. We are worried and concerned about the safety of House & properties constructed on Patti land bearing Patti No. 84/209 (New) cover by CS Dag No 1111 under 91/Meitei Langol Revenue Village located below Hill Colony, Langol, Imphal - 795004 but safety status of our properties which could not be confirmed by us till date (10.06.2023)

3. In this connection, I humbly request you to kindly Register FIR for unknown status of abandoned properties which is suspected to be Damaged/looted/burnt down by unknown miscreants immediately and shall be highly appreciated, if you could kindly inform us the action taken up by you in this regard and let us know the status of properties under report at the earliest.
