I regret to state that due to Volatile Riot Violence, arsonic attacks on human life, burning down of public properties etc in our Locality, Langol, Imphal from the night of May 3, 2023 our family is compelled to leave our home for the safety and security for our life and took refuge in 86 BN CRPF Camp located at Lamphelpat on May 4, 2023 and as the situation is worsening day by day, we left Imphal for seeking safer places for our life outside Manipur state on 07.05.2023.

2. As you are aware of reports/happenings of rampaging, looting, burning down and damaging of public properties by unknown miscreants in Langol Area, Imphal since the night of May 3, 2023. We are very worried and concerned about the safety of our House & properties constructed on Patta land bearing Patta No.231/3439 (New) cover by CS Dag No 1111/1571/2942 under 91/Meitei Langol Revenue Village located in GAMNGAI Veng, Phipijang, Langol, Imphal - 795004 and the safety status of our Home and House-hold properties which was could not be confirmed by us till date (10.06.2023)

3. In this connection, I humbly request you to kindly Register FIR for unknown status of properties which is suspected to be Damaged/looted/burnt down by unknown miscreants Immediately and shall be highly appreciated, if you could kindly inform us the action taken up by you in this regards and let us know the status of properties under report at the earliest.
