FIR STATEMENT

My name is H. Lalbiaklian and I have been residing at Changangei, Airport Road Opposite Tata Motors MGT, Imphal, Manipur. On the fateful day of May 4, 2023 at the break of dawn we made phone calls to almost everyone we knew searching for a possible way to travel to Churachandpur with escort. We have heard about the attack and torching down of our neighbouring locally viz Paite Veng by radical Meitei mobs the night before i.e. May 3, 2023. As we did not receive any positive response regarding the escort to Churachandpur so we asked around searching for a safe place to go. After several phone calls we learned that there was an army camp near our place of residence. So hurriedly we drove by our car to 165 Territorial Army camp near Imphal Airport which was about 3kms from our residence. We pleaded with the army on duty at the gate to take us in as we fear for our lives. He opened the gate for us and we hurriedly went inside with our car. Inside they welcomed us with tea and snacks and made us comfortable.

At around 10:30 AM we saw smoke engulfed from the side of our home from the camp and after a while we heard the news that our residential accommodation has been torched down by meitei radical groups. All of our belongings inside the house and our motorcycle has been burnt. Some the belongings which are worth mentioning are being listed and attached as Annexure I for your reference. Inside the camp we were taken good care by 165 Territorial Army personnel and they assured us that no harm will come to us inside the camp and they will protect us. They also requested not to move around much as the meitei community could see us from their rooftops and they have been making menace outside the gate demanding for the campers and the vehicles.

Even after the assurance of safety by the army inside the camp we all feared for our lives and being attacked inside the camp since we could hear the sound of gun fires and banging of electric post. Our nights were sleepless and days restless for the days and nights spent inside the camp. After much consideration we realized that it was not safe for us to stay in Imphal, Manipur so we managed to book flight tickets for Aizawl, the nearest destination from Imphal outside of Manipur. We were able to get tickets for 6th May 2023 (Saturday) to Kolkata. On the day of our departure we were escorted to the airport (which was about 1 km from our camp) by their convoy and were told to maintain silence inside the convoy for our safety. We managed to reach airport safely with the help of 165 TA Army after spending two nights and three days inside their camp. From Imphal we traveled to Kolkata and spent the night at Kolkata Airport as our next flight was in the morning. On 7th May 2023 (Sunday) morning at around 5:00 AM we checked in for our connecting flight from Kolkata to Agartala to Aizawl. We reached Aizawl safely at around 2pm on 7th May 2023 and were given warm welcome by our Mizo brethren's for which we are immensely grateful.

With the current situation prevailing in Manipur and for the fear of our lives, we cannot go back and file an FIR at the concerned police station. Hence we are filing Zero FIR here at the nearest police station in Churachandpur.
