STATEMENT OF THE INCIDENTS HAPPENING ON THE FATEFUL DAY OF 3rd MAY-4th MAY, 2023

On the 3rd May, 2023 Tribal Solidarity March was organized in all the hill district which was spearheaded by All Tribal Students Union (ATSUM) where a counter blockade was immediately called upon by organizations from the Meitei community. The solidarity march ends peacefully until the Meitei community's unruly mob set fire to the Anglo Kuki war Centenary Gate at Leisang, Churachandpur sparking the mayhem that ensued. State Police and Commando's aided the unruly mob of the Meitei community by acting as their shield and opening fire with automatic weapons on defenseless Kuki/Mizo/Zomi group resulting in burning of hundreds of tribal houses in a single night which escalated the situations.

In the intervening night of 3rd May,2023, residential houses and churches in Imphal belonging to the Chin/Kuki/Mizo/Zomi group were burnt and looted by the Meitei community under the watch of the State Forces. Old and young including children and infants have to escape the unruly mob that marched with iron rods, clubs and whatever that can pose a threat to defenseless small communities.

In fear of all these violence and conflicts met upon our tribal brothers, we decided to leave our residential house located at Changangei Ucheckon near Herbert School, Airport Road in the morning of 4th May, 2023 since churches and residential buildings in Paite Veng, a tribal locality which is only about 3 Km from our residence were burned and looted. We were unsure of where and how to escape as there were no Army or police forces but only the radical Meitei mob near us. It was our first priority to go to Churachandpur, but since we were informed by our Meitei friends that some youngsters wearing black shirt (which we later identified them as Arambai Tenggol and Meitei Leepun) were on duty at the Airport Road asking for Aadhaar card and those that belongs to the Chin/Kuki/Mizo/Zomi community were not spared. So, we started contacting for Police escort but to no avail we could not find any help from either the central or state forces. We were devastated, sad and at the same time in fear. After several phone calls to find any possible means of escaping we finally heard from our neighbor's that we could go to the 165 Territorial Army Camp near the Imphal Airport which is not very far away from our residence. It was already 9:30 a.m., so we packed whatever we could and drove with five vehicles to the Territorial Army Camp. There were 21 of us altogether including a pregnant lady and six children. Two of the cars that we were driving were halted along the road that is not far away from the Territorial Army gate by the radical Meitei who were holding clubs and stones in their hands. Thereafter, our car keys were taken by them and they demanded to show our Aadhar card. Then we were forced to evacuate our car which we unfortunately could not retrieve our documents and belongings that were kept in the trunk of our car. Our documents and belongings include laptops, educational certificates, luggage, several other important documents along with SBI, BOB and PNB Bank pass books and cheque books. Fortunately, we were rescued by the Territorial Army with the only clothes attached to us. A few minutes after the entry of the 165 Territorial Army camp, we were informed by the Army that the Arambai and Meitei Leepun had arrived and set fire to our car along with all our belongings and
