I the undersigned Mrs. Boboi Vaiphei w/o (Late) P. Mawia Vaiphei resident of Vaiphei Enclave, 91-meitei Langol, Imphal West, Manipur-795004 would like to bring to your kind notice the occurrence of crime committed on my house and property for kind registration of FIR. The particulars are as follows:

1. Place of incidence: Residence of Mrs Boboi Vaiphei w/o (Late) P. Mawia Vaiphei, Vaiphei Enclave, 91-Meitei Langol, Imphal West District, Manipur (1 km Approx. North of P.S Lamphelpat, Police Station: Lamphelpat Police Station Lamphelpat, Manipur)
2. Time of Incidence: 4th May, 2023 between 11 am to 6 pm.
3. Accused/Suspects:

Brief incident of the case:

On the day of May 4th around 11 am a violent mob numbering about 200-300 suspected members of the Arambai Tengol, Meitei Leepun & Meitei Scheduled Tribe Demand Committee of Manipur (STDCM) and others came with weapons and guns with the intention of causing harm to our lives and property by making criminal trespass, pelting stones, throwing kerosene bomb at my house and destroying my gate. They entered our house and looted the valuables like sofa sets, TVs etc. After thoroughly looting all the valuables the criminals set my house on fire and burning our vehicles and valuable documents namely Gas books, Pension Book Certificates of Class X, Class XII, Bachelor Degree and Master Degree certificates belonging to me, my son and daughter. Amidst the crime we somehow managed to escape and fled to Lamphelpat CRPF camp for safety.

This incident could not be reported earlier due to law and order situation and I had to evacuate family members from my locality and moved out of Imphal due to eminent threat to lives and also for the above reason I could not report the matter personally to the Lamphelpat Police Station.

Therefore, I earnestly request to take effective and stringent action against the perpetrators by registering FIR under relevant sections of India Penal Code (IPC).
