I hereby write this letter to draw your attention that in the past few days i.e., on the 6th of May 2023 @ 12:00 pm, the quarter allotted in the name of Shri SK John S/o SK Dartho Lamkang, residing at National Game Village, Zone-I, D/60, P.O./P.S. Lamphel, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 17,44,000/- (Rupees Seventeen Lakhs Forty Four Thousand) only comprising of my household item and personnel assets including two vehicle comprising of:

- I) Maruti Alto bearing Reg. No. MN03P 5640
- II) Honda Activa 6G bearing Reg. MN06S D6298 was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family members managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at D. Phailien, Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
