With reference to the subject cited above, I would like to lodge a complaint regarding the attack unleashed by a violent mob allegedly belonging to the Meitei/Meetei community on our properties and personal belongings in the early hours of the 4thof May, 2023 and which continued sporadically thereafter at my rented premises 'Salem House', Paite Veng, Sangaiprou, P.S. Lamphel, Imphal West - 795 001, Manipur.

In the mayhem, the miscreants burnt three vehicles, one of which is a Government vehicle (a white Maruti Suzuki SX4 bearing registration No. MN01S 1244) and two private vehicles (a dark brown Datsun Go bearing registration No. MN01AK 0399 and a white Maruti Suzuki M800 bearing registration No. MN02 4774), Educational certificates/records (Matriculation, Class XII and Graduation certificates), PAN Cards, College ID Cards, Medical records and personal belongings of MsChingzaningHangzo (wife), Ms Sara Lhingsianvung Songput (daughter). Ms Salome Vungthianching Songput (daughter) and Songput Kimneih Claire (daughter). Besides these, three Television sets (Sony 55", 43" and 21"), wooden furniture (teak sofa set), a wooden teak Diwan and four Laptops, one of which is a property of the NHP (IA Manipur), Indian Passport and PPO booklet (Pension Payment Order No. 112224709) of the undersigned are missing(A Detailed list of the properties and personal belongings is attached as an Annexure). The value of all the items missing/destroyed including cash is estimated to be more than Rs. 1,75,00,000/-(Rupees one Crore seventy fiveLakhs) only.

destation of the second When the mobs attacked, we had to flee for our lives and took shelter in the 1st Battalion Manipur Rifles' Relief Camp. Asnormalcy is yet to return and as we are deeply concerned about the safety for our liveswe have relocated to Churachandpur.

In view of the above facts and circumstances, you are requested to kindly:

- (i) Register a Zero FIR
- Facilitate an investigation into the events prior to and leading to the (ii) incidents of vandalism, theft, arson and looting and book the culprits immediately so as to prevent the recurrence of such undesirable incidents in future.

Thanking you in anticipation as I look forward to a favourable consideration of my request for registering a Zero FIR at the earliest.
