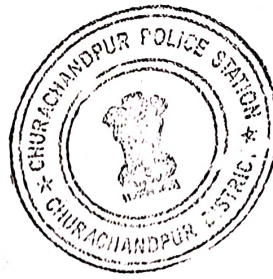

Subject:- Report on looting, vandalism and burning of properties at government quarter.

Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 4th of May 2023 @ 07:00 pm, the residence quarter allotted in my name of Mrs. Paominthang Khongsai at Langol Housing Complex Type-III H/13, situated at Langol, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and destroyed/looted, vandalized and gutted/burnt down all my household item and personnel assets and one License Shop registered under the name and style of "Choi Beauty Salon & Spa" bearing registration no. IMC/51C5/18, a total loss estimated to be at an amount of Rs. 36,00,000/- (Rupees Thirty Six Lakhs) only was lost by the unlawful activities/action of the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
