

Subject: - Complaint Report.



Sir,

I am to state that on 04/05/2023 at about 2:00 pm, our locality Khongsai Veng, Laipham Khunou Makha Leikai under Lamphel PS (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community.

As a result, many houses and properties were destroyed and burnt to ashes. My House No. 2 (two) registered in the name of my son Clay Khongsai was also destroyed by the mob and crores of properties were looted and burnt to ashes. Further, the rioters also set on fire the valuables including gold ornaments and cash worth 20 (Twenty) lakhs. Total loss of properties at my residence would be about 1 (One) Crores: -

- 1) Immovable property - House building having G+1.
- 2) Movable property - Gold ornaments weighing about 3 tolas, Kitchen materials, furniture's Wooden and iron Almirah, Led TV, Washing machine etc.

It is therefore requested to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. Necessary evidential photos enclosed.
