I hereby write this letter to draw your attention that in the past few days *i.e.*, on the 6th of May 2023 @ 12:00 pm, the quarter allotted in my name at Q. No. T/B-32 Zone-IV, National Game Village, P.S. Lamphel, Imphal West- 795004, was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open the gate and a total loss estimated to be at an amount of Rs. 15,00,000/- (Rupees Fifteen Lakhs) only comprising of my household item and personnel assets was looted, vandalized and gutted/burnt down by the said armed meetei/meitei radicals.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Mata Village, Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
