I am to bring to your notice that on the 4th of May 2023 between 9 PM to 1 AM, rManipur residence located at National Games Village, Qtr No. B 241, Zone 1, Langol, was attacked by group. of Meetei/Meitei goons numbering about 500 to 1000 men.

These criminals broke open my gate and looted all valuable property from my Owned/Rental house, and premises worth Rupees 9,46,550.00 (approx.) and they burnt down all the remaining things.

Fortunately, me and my family managed to escape from these criminals who even tried to kill us or burn us alive.

Therefore, with utmost respect I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Codes.
