13,77,200 (Thirteen Lakhs Seventy Three Thousands and Two Hundreds) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to 1st MR (Manipur Rifle) for our safety on the same fateful day and finally left the camp on 6th May 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
