Sir,

With due respect, I the undersigned would like to lay down few lines before you for your kind consideration and necessary action.

That, I am allotted Govt. Quarter No. D/III-51 at Langol Housing Complex, PO & PS Lamphel, Imphal West.

That, due to the recent prevailing situation in the state, on the 4th May, 2023, I have left my residential Quarter to a safety place.

That, on dated 2nd June, 2023 at around 10:00 am, it has come to my knowledge that, my residential Quarter was looted by some unknown miscreants by breaking the gate and door which was locked. Property including some Furniture, Household Electronic goods, Clothes & Garments, Important books, Kitchen and Utensil items and other valuable assets has been looted by the miscreants. The total amount of property looted is about Rs. 7,00,000/- (Seven Lakhs only) approximately.

Further, miscreants suspected to be from Meitei community has again broke into my Quarter and illegally occupied and stayed in my house in my absence and without my knowledge. There is an apprehension that my left behind properties may be again stolen by the illegal occupants.

I could not report the incident to my concern Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request you to take necessary action against the miscreants engaged in breaking my house and looting my properties and the illegal occupants of my residential Quarter at the earliest in the interest of Justice.
