I have the honour to state that, On 05-05-2023 at around 8:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 400-500 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality at my Rented house at Phaipijang Hebron veng, Langol, Imphal West District, Manipur about 46 km South from Saikul-PS. They vandalised my rented house and looted all the moveable properties, Furnitures, Utensils, Kitchen Wares, Electrical and and Electronic items, rice and grains and one Rickshaw etc. leaving all of us homeless.

The approximate value of lost property is calculated at about Rs. 5,00,000./(Five lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
