Sir,

I have the honour to state that, on 04-05-2023 at around 9:00 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at Langol type 3 E-59, Imphal West about 45 km South from Saikul-PS, after looted all the moveable properties and cash, they burnt my household properties like Furnitures, Electronic items, Utensils, Clothes, books, documents, food and grains including two wheeler (1). Ntorque (New) No Regd number (2). Activa 4G Regd No MN01AD9107 (3). Jupiter Scooty Regd No. MN065C5534 (4). Royal enfield (New) No Regd number (5) Ntorque (new) No Regd number and leaving us homeless.

The approximate value of lost property is calculated at about Rs. 50,00,000. (Fifty lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
