Sir.

I have the honour to state that, On 04-05-2023 at around 09:30 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at Tarung KRBCA colony, Imphal West Dist. Manipur, about 44 km South from Saikul-PS. They burnt my rented house to ashes after vandalising and looting all the moveable properties, Furnitures, Jewellery, Utensils, Kitchen Wares, Electrical and Electronic items, Books, important document etc and leaving us homeless.

The approximate value of lost property is calculated at about Rs.8,00,000/- (Eight lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
