Subject: - Complaint Report.

Sir.

I am to state that on 04/05/2023 at about 2:00 pm, our locality Khongsai Veng, Laipham Khunnou Makha Leikai under Lamphel PS (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to a Meitei community.

As a result, many houses and properties were destroyed and burnt to ashes. My residence House No. 15 (fifteen) first floor left wing flat of Khongsai Veng was also destroyed by the mob and crores of properties were looted and burnt notably. Further, the rioters also set on fire the valuables including gold ornaments and cash worth 2 (two) lakhs. Total loss of properties at my residence flat would be about Rs. 7 (seven) lakhs:-

- 1) Tenant list and their belonging
  - i. Gold ornaments weighing about 2 tolas, Kitchen materials, furniture's Wooden and iron Almirah, Led TV, Washing machine, utility items etc.
  - ii. Monitor 32" BenQ, A3 Epson L1300 printer, UPS, CPU, Work Table.
  - iii. Gym materials, Treadmill, Gym cycle, gym carpets.
  - iv. Kuki Customary clothes, such as Saipikhup & Khamtang about 25 nos.

It is therefore requested to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. Necessary evidential photos enclosed.
