Sub:- An application under S.154(3) of Criminal Procedure Code against the refusal to register FIR by the Mayang Imphal Police Station against Md.Rahimuddin (54), S/o (L) Md Kayamuddin of Mayang Imphal Bengoon (now working in 4IRB, Korengei)

Sir,

With due regard it is bought to your knowledge that I went to lodge an FIR against one Md.Rahimuddin at Mayang Imphal Police Station but refused to register an FIR.Hence this application.

1. That one Md.Rahimuddin, S/o (L) Md.Kayamuddin took a sum of Rs.2,00,000/- (Rupees two lakh)only from me on 20-04-2022 assuring to avail me a land but he failed to do so.
2. That when I asked for repayment of the said amount he repeatedly fixed time for repayment of the said amount. As he fixed 12-12-2023 for such repayment I went to his house at/around 7.30 P.M for the said amount as he is also in my locality.

However, on seeing me he started to abuse me with filthy words and rushed to me in very angry manner and slapped me 2/3 times and warned me with dire consequences if comes again and I was pushed out holding my neck and told me "you can do whatever you like, go and complain to your deceased father or the DGP or the CM". In fact, he did not respect me as I am a Widow.

3. That after such incident I went to the Mayang Imphal Police Station for lodging an FIR against him for assaulting me physically and using Criminal force to a women with intent to outrage my modesty. But since the accused is working as a Rifleman having No. 0694057 of 4IRB the MI-PS refused to register a case against him instead I was advised to compromise.

So, I am reporting the matter to your goodself for doing the needful to punish the accused as per law by registering an FIR against the accused and obliged
