Subject: - Complaint Report.

Sir,

I am to state that on 04/05/2023 at about 2:00 pm, our locality Khongsai Veng, Laipham Khunnou Makha Leikai under Lamphel PS (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the meitei community.

As a result, many houses and properties were destroyed and burnt to ashes. My residence i.e. House No. 22 of Khongsai Veng was also destroyed by the mob and crores of properties were looted and burnt notably, One Car, One Activa, which were parked inside the house compound were burnt to ashes. Further, the rioters also set on fire the valuables including gold ornaments, valuable Kuki customary necklace & ladies petticoats and cash worth 21 (twenty-one) lakhs. Total loss of properties at my residence would be about 90 (ninety) lakhs: -

- 1) Immovable property -
- 2) Movable property -
  - i. One Alto Car of Silver colour bearing registration number AS-01-EQ-5483.
  - ii. One Activa white colour bearing registration number MN01E 7797.
  - iii. Gold ornaments (necklace/finger ring/earring) all weighing about four tolas.
  - iv. One Desktop set, One large MI TV.

It is therefore requested to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. Necessary evidential photos enclosed.
