I, the undersigned occupant of Quarter No. CP-Type IV/32, Lamphel, Imphal West District would like to bring to your kind notice the occurrence of crime committed on my house and properties for kind registration of FIR.

On 26th May, 2023 suspected members of Arambai Tengol, Meitei Lipi and some unknown miscreants enter my house through the back door and ransacked my house and looted many valuable properties worth around 20 lakhs (twenty lakhs).

This incident could not be reported earlier due to law and order problems and I have to evacuate my family members out of Imphal to other safer place.

It is therefore requested to kindly take appropriate stringent action against the perpetrators by registering an FIR.
