Sir,

I would like to report that on 05/05/2023 at around 11:00 AM some unknown miscreants armed with deadly weapons have assembled at Langol with an intent to cause harm and destroy properties. At around 11:30 AM the unknown miscreants have started attacking the locality in which my quarter No. Type-III/E-2, Langol Housing Complex was vandalized, ransacked and looted by the unknown miscreants and have stolen away all valuable properties within the house and its premises estimated to be around Rs 10,00,000. Fearing for our life we deserted the locality for a safer place reaching Churachandpur.

In this regard I would like to request you to kindly register a case against the unknown miscreants and take necessary legal action at the earliest.
