my residence was attacked by a group of people numbering 100 to 200 men
suspected to be members called Arambai Tenggol, Meetei Leepun and
others.

These criminals broke my gate/s and looted every valuable properties
from my house premises worth Rupees ...5,192,100.../- (approx.)
and they burnt down all the remaining things. Fortunately, me and my
family managed to escape from these criminals who even tried to kill or burn
us alive.

I request you to take strong actions against the perpetrators by registering
ZERO FIR under relevant criminal sections of the Indian Penal Codes.
