Sir,

I am to state that on 04/05/2023 at about 2:00 pm, our locality Khongsai Veng, Laipham Khunnou Makha Leikai under Lamphel PS (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei

As a result, many houses and properties were destroyed and burnt to ashes. My residence i.e. House No. 22 of Khongsai Veng was also destroyed by the mob and crores of properties were looted and burnt notably, One Activa, which was parked inside the house compound was burnt to ashes. Further, the rioters also set on fire the valuables including gold ornaments and cash worth 7 (seven) lakhs. Total loss of properties at my residence would be about 10 (ten) lakhs: -

- 1) Immovable property -
- 2) Movable property -
 - One Activa MN06S G 3666. i.
 - Gold ornaments (necklace/finger ring) all weighing about 2 tolas. ii.
 - One Desktop set with one HP LaserJet printer.

It is therefore requested to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. Necessary evidential photos enclosed.
