I am to bring to your notice that on the 4th May 2023
Between 6:30 am and 7:00 am, My residence
located at, Langol Housing Complex
was attacked by a Group of Meitei/Meitei's goons numbering 500 to 1000 men.

These criminals broke open my gate(s) and looted every valuable property from my owned / rental house, and premises worth Rupees 10,75,000 (approx) and they burnt down all the remaining things.

Fortunately, me and my family managed to escape from these criminals who even tried to kill or burn us alive.

Therefore, with utmost Respect I request you to take strong action against the perpetrators by registering an FIR under relevant sections of the Indian Penal Codes.
