Subject : Report on looting, vandalism and destruction of property.

Sir,

I am constrained to inform you that on the 4th May, 2023 at about 6:00 – 6:30 p.m, a group of mobs belonging to the Meeitei Community armed with Automatic Rifles, sharp weapons etc, forcefully entered my rented Government Quarter at Zone-3/C-6, Games Village, Imphal West and looted all the movable properties and destroyed and vandalised all the immovable properties. During the whole events, I took shelter at a CRPF Relief Camp and then on proceeded towards Churachandpur and took shelter presently.

Household Items worth approximately Rs. 6,00,000/- (Rupees Six Lakhs) only have been looted and vandalised by the Mobs.

In connection with the above incident, I have the honour to request you to kindly register a formal F.I.R and take necessary legal actions.
