

The following items were looted from my house:

3. 1 (one) bookshet Almirah along with dining table set – Rs. 75,000/-
4. 2 (two) wooden sofa set along with coaten set –Rs. 1,60,000/-
5. 3 (three) bed and 1 (one) bed box along with the mattress –Rs. 1,50,000/-
6. 5 (five) TV set along with 12v Solar set –Rs. 1,30,000/-
7. 1 (one) desktop set and 1 (one) Lenovo Laptop- Rs. 115,000/-
8. 1 (one) Fridge and washing machine- Rs. 80,000/-
9. 4 (four) Cylinder and a gas stove-Rs. 20,000/-
