I am a government employee serving as Havildar bearing ID No. B 1214 under the 1<sup>st</sup> Battalion of Manipur Rifle, Govt. of Manipur located at Imphal issued by the concern authority.

That, I was given an allotted Quarter being No. D/52, Zone-1, National Games Village, by the Home Department and has been living till the incident of attack occurred.

That, I would like to report and register a cognizable offence carried out against me and my family on the morning of 4<sup>th</sup> May, 2023 at around 8 pm by the Meitei Community, who were armed with pistol, manchette and knife. Whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of valley based CSO's.

Due to such attacked carried out against me and my families, being in state of vulnerable. Me and my family numbering Male-3 and female-5 in total 8 members, fearing to lose our life, had fled from our resident i.e Qtr. No. D/52, Zone-1, National Games Village, Imphal, PO- Lamphelpat, PS- Lamphel.

As such, we have been taking Shelter at Tuibong Village in my elder sister namely Singnem Singsit.

Upon inquiry, my Quarter was ransacked, properties were looted and taken away on broad-day light.

I, therefore, seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous crime against me and my families for the end of justice.
