Sir.

I am to state that on 04/05/2023 at about 2:00 pm, our locality Khongsai Veng, Laipham Khunnou Makha Leikai under Lamphel PS (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to Meitei community.

As a result, many houses and properties were destroyed and burnt to ashes. My residence i.e. House No. 22 of Khongsai Veng, was also destroyed by the mob and crores of properties were looted and burnt notably, One Celerio Car, two imported bicycles, which were parked inside the house compound were burnt to ashes. Further, the rioters also set on fire the valuables including gold ornaments, valuable Kuki customary necklace & ladies petticoats and cash worth 20 (twenty) lakhs. Total loss of properties at my residence would be about Rs. 80 (eighty) lakhs :-
