Subject: - Complaint Report.

Sir,

I am to state that on 04/05/2023 at about 2:00 pm, our locality Khongsai Veng, Laipham Khunnou Makha Leikai under Lamphel PS (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to Meitei community.

As a result, many houses and properties were destroyed and burnt to ashes. My residence i.e. House No. 22 of Khongsai Veng, was also destroyed by the mob and crores of properties were looted and burnt notably, One Celerio Car, two imported bicycles, which were parked inside the house compound were burnt to ashes. Further, the rioters also set on fire the valuables including gold ornaments, valuable Kuki customary necklace & ladies petticoats and cash worth 20 (twenty) lakhs. Total loss of properties at my residence would be about Rs. 80 (eighty) lakhs :-

- ii. One Activa Bearing Registration Nill.
- iii. Two bicycle of Mountain bike and road race.
- iv. Gold ornaments (necklace/finger ring/earring) all weighing about four tolas.
- v. One Desktop set with Epson L565 all in one printer, One large MI TV and one large Sony TV.
- vi. One Asus Laptop i7.
- vii. *Misao Car and Manipur Police Car books & connection documents.*

It is therefore requested to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. Necessary evidential photos enclosed.
