Subject: - Complaint Report.

Sir,

I am to state that on 04/05/2023 at about 2:00 pm, our locality Khongsai Veng, Laipham Khunnou Makha Leikai under Lamphel PS (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to a Meitei community.

As a result, many houses and properties were destroyed and burnt to ashes. My House, having No. 33 (thirty-three) of Khongsai Veng was also destroyed by the mob and crores of properties were looted and burnt notably. Further, the rioters also set on fire the house structure and reduced to ashes including the valuables gold ornaments and cash worth 5 (five) lakhs. Total loss of properties at my residence would be about Rs. 10 (ten) lakhs :-

- 1) Immovable property - Kutcha building G+1 having three rooms each ground floor and first floor.
- 2) Tenant list and their belonging -
  - i. Chongnunem Khongsai (20 years) of Gallam village, Kangpokpi district.
  - ii. Nemneihat Khongsai (23 years) of Mongkot village, Ukhrul district.
  - iii. Mr. Jangminthang Khongsai (25 years) of Twichamphai village, Kangpokpi district.
  - iv. Hatboithem Khongsai (20 years) of Saichang village, Kangpokpi district.

(details of the tenant belongings will be follows)

It is therefore requested to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. Necessary evidential photos enclosed.
