I hereby inform that on 04-05-2023 at around 4:30 am, during the ethnic problem, some unknown mob broke my gate and entered forcefully into my new house at Game Village Zone-2, Quarter No. B230, Imphal West. The unknown mob destroyed the properties, took away the valuable properties including Pleasure Scooty B/R No. MN06SB-3065. Fortunately our family escaped unhurt for our livelihood. Due to the present prevailing Ethnic problem in the state, the matter could be able to report in time.
